

Big MaMa Earth Certified Education Recycling Centers

The Industry

The recycling industry is a multi-billion dollar a year industry in the collection and processing of CRV beverage containers and electronic waste called e-Waste.

The Problem

The American consumer is being bombarded with slogans to recycle, reduce and reuse, and to bring their recyclables and e-Waste for collection at events and or processing centers for processing.

An alarming fact is that many e-Waste collectors and processors unknowingly or willingly export hazardous e-Waste for profit to third world countries for unsupervised and dangerous processing.

In addition, collectors and processors of beverage containers are being cited and shut down by state and federal regulatory agencies for improper collection and processing.

The Solution

The solution is certified and accountable collectors and processors. The Basal Action Network known as (BAN) is offering e-Waste collectors and processors training and certification in the proper collection and processing of e-Waste known as "e-Steward Certified". All BAN members must comply with strict compliance for e-Waste processing in the US and will not export any e-Waste to third world countries.

BAN nominated Big MaMa Earth to receive the first e-Steward Enterprise certification for its dedication in the education and awareness of the e-Waste issue. Big MaMa Earth will only partner with other certified e-Steward Enterprise and processors. Big MaMa Earth will also be working with CAL Recycle and applying for a grant for the education and collection of beverage containers in CA schools.

Big MaMa Earth Certified Recycling & Education Centers

Big MaMa Earth will design, develop and operate Big MaMa Earth Collection & Processing Centers for the collection and processing of CRV beverage containers, such as aluminum cans and bottles, plastic bottles, and plastic milk containers and glass bottles.

We will also collect e-Waste (cell phones, computers, electronic devices, etc.) at our collection centers and ship to e-Steward certified processors for processing. In addition, we will collect electronic toys and games for refurbishing to be given to needy children. In addition, we will also be collecting printer cartridges for refurbishing and have established relationships with processors.

Time Table

We are viewing locations in Southern CA, for our first collection and processing center. We are considering a location in the City of Perris in Riverside County. Permits and licenses are being applied for and we have on staff a consultant with 20 years' experience in the operation of a certified collection and processing plant to guide us through the initial startup phase.

The normal turnaround time is about 90 days to have a CA beverage container recycling plant in operation and compliance.

While we are completing the startup phase on the first BMME Collection Center and processing plant, we have established business relationships with certified recyclers to process our collected materials from events until we are in operation.

Expansion Plans

We plan to open one main processing center and one small collection site at a shopping center parking lot. As business and awareness increases, we will expand into multiple processing centers within a 50 mile radius and expand small collection sites into multiple shopping center parking lots throughout CA, and as demand increases, expand throughout the US.

What makes us Different?

Big MaMa Earth will be the first collection center to offer an educational element at its centers and processing facility, whereby recycling information will be taught. We will also offer schools field trip opportunities for their students to view a processing plant in operation and understand the life cycle of the products above. This will instill an ownership in students about recycling, reducing and reusing.
